A few years back, with the limitations imposed by email servers, an alternate venue was researched that would best allow our organization to distribute a large number of emails without violating any one server's rules.

The RSPA joined a bulk email service through a company called "MailChimp."

The RSPA currently has approximately 800 members who are registered to receive their quarterly newsletter through MailChimp, and every quarter for the past two years, 20 to 30 members choose to opt out of receiving the newsletter through MailChimp. While most do not give a reason for opting out; recently two members did give a reason with the emailing of the 2021

Fall Newsletter. One said, "too Spammy", another said, "I didn't sign up for this." Until we can find a better solution, please be patient, and I ask you do not UNSUBSCRIBE, unless you no longer want to receive the newsletter.

I have also been trying to use the RSPA gmail account more frequently to send and receive individual emails to our members. You may still receive a bulk email from me under martinezrichard@live.com.

#### **MEDICARE!!!!** WHO NEEDS IT?

Unfortunately, if you belong to the RSPA, you already have it, or are joyfully looking forward to our government taking control of your health care. You have a seven month window of your 65th birthday to apply, plus how are you going to pay for medicare?

The first step is to go to SSA.gov and register. Within three months prior and up to three months after your 65th birthday you must apply. If you are drawing social security prior to your full retirement age, no worries, the SSA will automatically deduct your portion of medicare you pay for Part B. Part A is automatic and does not cost you anything.

Things get a little tricky if you have an older spouse who is already on medicare. Now you have to choose a supplemental plan. Otherwise, your current ISP medical takes care of your vision, dental and prescriptions; AKA Parts C & D.

If you are not drawing social security benefits, or do not qualify, no worries; SSA will bill you quarterly.
